School Description and Mission Statement (School Year 2019-20)

Golden West Elementary school was established in 1961. It is located in central Manteca. It is home to the Golden West 49ers and 49er Pride. We are loud and proud and especially, as we share our school mantra: Pride in Yourself; Pride in Your School; Pride in Everything You Do! We serve over five hundred students from our neighborhood families in grades Kindergarten through Eighth Grade, as well as hosting Pre-School and Transitional Kindergarten classes. We have a faculty that is committed to meeting behavioral, health, social-emotional, and academic needs of our students. Each teacher is qualified to provide differentiated instruction to meet the diverse needs of our students. You will find instructional strategies that are research-based and targeted to the Common Core State Standards. Students have opportunities to connect with books, write to their grade level genres, and apply their mathematical knowledge.

Golden West's Mission is to ensure individual student growth toward mastery of state standards, promote nutritional and social-emotional well-being for each of our students in an engaging, and safe learning environment. We are committed to using data to identify student needs; to inform decisions and to monitor and evaluate progress toward our goals.

Golden West plan includes three goals to address student performance.

Goal 1: Students will have equitable access to core curriculum to facilitate students meeting and/or exceeding grade level standards. Effective Tier 1 instruction will be implemented along with Tier 2 Interventions to increase the number of students meeting grade level standards. This goal aligns with MUSD's goal to maximize student achievement by supporting effective instruction aligned to state standards.

Goals 2 is to Increase the days all students are in attendance at school by reducing chronic absenteeism and suspensions for all students through implementation of PBIS, which includes interventions and supports to create a positive, safe learning environment in which students attend, increasing their opportunity to make progress toward state standards. This goal aligns with MUSD's goal to provide a safe, healthful, and expansive environment.

Goal 3 is to provide students with educational experiences; cultural experiences; career and college experiences, academic & extracurricular experiences; and Social-emotional learning skills to promote school attendance, school connectedness; engagement; and to acquire background knowledge and understanding of state standards. This goal aligns with MUSD's goal to promote engaging learning opportunities for all students, inclusive of emerging students, inside and outside the classroom

School Facility Conditions and Planned Improvements (Most Recent Year)

The District takes great effort to ensure that all schools are clean, safe, and functional. To assist in this effort, the District uses the Facility Inspection Tool (FIT) instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the District Office. Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

Age of School Buildings

Golden West School was completed in 1964. The administration building was finished in 1961 along with a library, multi-purpose room, and several classrooms. Portable classrooms have been added. In the year 2000, the community gymnasium was built at Golden West as a result of a partnership with the City of Manteca. In 2015, the campus was modernized. This modernization built a new administration/classroom building, a new kitchen, converted existing administration space to new classrooms and removed several portable classrooms. After modernization the campus has 38 classrooms.

Maintenance and Repair

District maintenance staff ensures that repairs necessary to keep schools in good working order are completed in a timely manner. A work order process is used to ensure efficient service and emergency repairs are given the highest priority.

Cleaning Process and Schedule

The District's governing Board has adopted cleaning standards for all schools in the District. A summary of these standards is available at the school office and at the District Office. Staff works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Program

The District allocates funding for deferred maintenance. The Deferred Maintenance Program includes funding for replacement of existing school building components so that the educational process may safely continue. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, wall systems, floor systems, etc. The District's 2019-2020 budget allocated \$640,000 to address deferred maintenance needs throughout the district.

Modernization Projects

The District is currently planning to renovate and modernize its schools based upon the District's 2014 Facility Master plan. As part of that activity there are projects planned at the campus which will be completed through the use of local funds. State funding will also be sought for those projects which may be eligible for modernization funding. Modernization of the existing campus was completed in 2017.

School Safety Plan (School Year 2019-20)

All school sites in the Manteca Unified School District annually update the Disaster Plan and School Safety Plan. The plan was revised by Safe Schools Consultants and Site Administration according to the required adoption process with appropriate School Site Council public hearings and School Safety Planning Committee input. Teachers and staff annually receive training on disaster procedures. Teachers and staff received ongoing training throughout the 2019-2020 school year in order to meet the appropriate guidelines established by the state. The safety plans are confirmed and approved by March 1, 2020.

Manteca Unified School District continues to make strides in the improvement of the educational climate and reduced disruptions in the classroom by “putting kids first” and asking the question, “Is it good for the children?” The safety of students and the security of campuses are high priorities in MUSD. School personnel and students participate in monthly disaster preparedness drills including specific procedures for fire, earthquake, flood, civil disturbance, and hazardous chemical situations. The school sites also focus on establishing goals that are needed.

The District has established procedures for submitting complaints against personnel and programs. An information brochure, policies, and forms are available to the public at the school site, on the District’s website, and in all offices. Also, a nondiscrimination/harassment report form is used to help staff in reporting and tracking data.

Our schools work hard to improve academic achievement and provide alternative programming for “at risk” students. In addition, authorized prevention activities include conflict resolution strategies, before and after school programs, and district-wide efforts to prevent illegal gang activities with Drug Free and Tobacco Free School Zones clearly established and posted. Our District seeks grants and utilizes the Health Services Department to meet the health and counseling needs of students.

Types of Services Funded (Fiscal Year 2018-19)

All Manteca schools receive equal allocations of general fund support for staffing, instructional materials and supplies, custodian needs, and other uses. Funding for the support services such as maintenance of buildings and grounds, utilities, and student transportation is budgeted on a district-wide, centralized basis and provided to each school site-based on the unique needs of the individual school.

In addition to its support from the local general fund, each school in the Manteca Unified School District receives yearly allocations from various state and federal categorical programs. The purposes of these categorical programs range from improving the quality of the total instructional program for all students to addressing the unique needs of special groups of students such as limited-English proficient, academically deficient, and students at risk of dropping out of school

As a district we then select our major focus areas for staff development for each school year and then plan out our district professional learning calendar. Manteca Unified provides a variety of professional development methods through pull-out days, after-school trainings, conferences, observations, mentoring, and live/archived webinars. In addition, teachers are supported during implementation through in-person coaching, virtual coaching, and principal/staff meetings.
