School Description and Mission Statement (School Year 2019-20)

About Our School

Joseph Widmer Elementary is focused on providing rigorous, standards-aligned instruction to ensure all students work towards mastery of the standards. The use of data to drive instructional decisions, the leveraging of resources and support for students is being developed and implemented. This process led to the recognition of the need for struggling readers in the primary grades. Joseph Widmer school now employs a reading specialist who provides Tier 2 supports for twenty of our lowest readers in first and second grades. Tutorial support for additional struggling readers in grades first through third are provided in tutorial. English language learners are offered bilingual aid support and our emerging students are also offered a Rosetta Stone Tutorial.

Joseph Widmer also continues to focus on the development of a positive, safe school environment in which we teach desired behaviors, acknowledge and celebrate success while setting firm, clear expectations and applying appropriate consequences as necessary. Our staff is in it's second year of full PBIS tier 1 implementation and is continuing to adjust this program while developing tier 2 supports. We are implementing a data collection program called five-star students to amass data on the positive behaviors of our students. We have also begun to proactively address student behavior through the implementation of a social emotional learning program.

School Description and Mission Statement

Joseph Widmer, Jr. Elementary School, located in the city of Lathrop, is one of twenty K-8 elementary schools in the Manteca Unified School District. It is a welcoming, inviting school of approximately 800 students who live in the housing development that surrounds the school. The school opened its doors in the 2001-2002 school year. We have 27 regular education teachers, two full-time resource specialist teachers who support students in grades k-8, and four special day classes for moderate to severely handicapped students in grades k-8. We also employ a full-time speech pathologist, a part-time speech pathologist, a fulltime educational psychologist, and one full-time crisis counselor. Occupational therapists, a BCBA, and an adaptive PE specialist provided services on site on an as needed basis. We have a vibrant Parent Teacher Club that raises money to support student programs that enrich and enhance student education.

Our mission statement: Through smart actions and decisions, MUSD will work together using meaningful, measurable and aligned data for all students to achieve mastery of grade level standards in all subjects based on their unique educational pathway in a safe environment inclusive of design, security and climate.

Vision: Every student works to achieve grade level standards, feels safe and is supported to realize individual success

School Facility Conditions and Planned Improvements (Most Recent Year)

The District takes great effort to ensure that all schools are clean, safe, and functional. To assist in this effort, the District uses the Facility Inspection Tool (FIT) instrument developed by the State of California Office of Public School Construction. Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

Age of School Buildings

Joseph Widmer School was completed in 2000 including the administration building, library, multi-purpose room, gymnasium, and classrooms. There are 44 total classrooms.

Maintenance and Repair

District maintenance staff ensures that repairs necessary to keep schools in good working order are completed in a timely manner. A work order process is used to ensure efficient service and emergency repairs are given the highest priority.

Cleaning Process and Schedule

The District's governing Board has adopted cleaning standards for all schools in the District. A summary of these standards is available at the school office and at the District Office. Staff works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Program

The District allocates funding for deferred maintenance. The Deferred Maintenance Program includes funding for replacement of existing school building components so that the educational process may safely continue. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, wall systems, floor systems, etc. The District's 2019-2020 budget allocated \$640,000 to address deferred maintenance needs throughout the district.

Modernization Projects

The District is currently planning to renovate and modernize its schools based upon the District's 2014 Facility Master plan. As part of that activity there are projects planned at the campus which will be completed through the use of local funds. State funding will also be sought for those projects which may be eligible for modernization.

School Safety Plan (School Year 2019-20)

All school sites in the Manteca Unified School District annually update the Disaster Plan and School Safety Plan. The plan was revised by Safe Schools Consultants and Site Administration according to the required adoption process with appropriate School Site Council public hearings and School Safety Planning Committee input. Teachers and staff annually receive training on disaster procedures. Teachers and staff received ongoing training throughout the 2019-2020 school year in order to meet the appropriate guidelines established by the state. The safety plans are confirmed and approved by March 1, 2020.

Manteca Unified School District continues to make strides in the improvement of the educational climate and reduced disruptions in the classroom by “putting kids first” and asking the question, “Is it good for the children?” The safety of students and the security of campuses are high priorities in MUSD. School personnel and students participate in monthly disaster preparedness drills including specific procedures for fire, earthquake, flood, civil disturbance, and hazardous chemical situations. The school sites also focus on establishing goals that are needed.

The District has established procedures for submitting complaints against personnel and programs. An information brochure, policies, and forms are available to the public at the school site, on the District’s website, and in all offices. Also, a nondiscrimination/harassment report form is used to help staff in reporting and tracking data.

Our schools work hard to improve academic achievement and provide alternative programming for “at risk” students. In addition, authorized prevention activities include conflict resolution strategies, before and after school programs, and district-wide efforts to prevent illegal gang activities with Drug Free and Tobacco Free School Zones clearly established and posted. Our District seeks grants and utilizes the Health Services Department to meet the health and counseling needs of students.

Types of Services Funded (Fiscal Year 2018-19)

All Manteca schools receive equal allocations of general fund support for staffing, instructional materials and supplies, custodian needs, and other uses. Funding for the support services such as maintenance of buildings and grounds, utilities, and student transportation is budgeted on a district-wide, centralized basis and provided to each school site-based on the unique needs of the individual school.

In addition to its support from the local general fund, each school in the Manteca Unified School District receives yearly allocations from various state and federal categorical programs. The purposes of these categorical programs range from improving the quality of the total instructional program for all students to addressing the unique needs of special groups of students such as limited-English proficient, academically deficient, and students at risk of dropping out of school

Manteca Unified School District continuously analyzes data to determine professional development needs. As a district we then select our major focus areas for staff development for each school year and then plan out our district professional learning calendar. Manteca Unified provides a variety of professional development methods through pull-out days, after-school trainings, conferences, observations, mentoring, and live/archived webinars. In addition, teachers are supported during implementation through in-person coaching, virtual coaching, and principal/staff meetings.
